

Members of the United States Senate,

On behalf of our more than 1,250 active groups and of the more than 127,000 student activists we've trained across the nation, I urge you to oppose President Joe Biden's radical pick for the Supreme Court, Judge Ketanji Brown Jackson.

Millennials and Gen Z are now <u>almost one-third of the electorate</u>, which is why we engage daily in recruiting, training, and organizing single issue, pro-life voters who represent the future of the pro-life movement. This nomination represents a direct attack on much of SFLAction's work across the country, and we ask you to vote NO on Judge Ketanji Brown Jackson for the current Supreme Court vacancy.

Judge Ketanji Brown Jackson's presence at the Supreme Court would present a unique and profound threat to the work of the Pro-Life Generation. She has a proven track record of opposing even late term limits to abortion, seen in her work on behalf of <u>partial birth abortion</u>, when a state passed what was then a rare protective measure. Today passing pro-life laws is much more frequent as voters engage more directly.

Judge Ketanji Brown Jackson's attacks on peaceful free speech, including <u>student-initiated</u> <u>prayer</u> and <u>peaceful gatherings outside abortion vendors</u>, show that she is prejudiced against people whose ideas she does not share and will use her power against them.

Groups like SFLAction rely on judges who value the First Amendment, and we have taken our free speech cases to court repeatedly over our 16 years in operation, arguing that we need a level playing field in access and opportunity. For example, our sister organization, Students for Life of America, participated in an amicus brief in *Price v. City of Chicago*, opposing efforts to make it criminal to speak for the preborn near the locations of their deaths.

Additionally, the judge interfered with efforts to <u>redirect funds from abortion-infused</u> teen pregnancy programs, insisting that funds initiated during the Obama Administration had to be spent no matter the change in the Oval office.

Judge Ketanji Brown Jackson prepares to come to the Supreme Court in a judge's robe, hiding an eraser that she plans to use like a legislator to re-write what she doesn't like and adding where it suits her. This capacity is seen in critique of her <u>"considerable judicial overreach"</u>. In fact, President Biden seemed to be looking for a candidate who would ignore the law in favor of a private agenda. Jonathan Turley's analysis

in <u>The Hill</u> noted, "President Biden stressed that his nominee must follow a <u>"living constitution" approach</u>, including a broad view of "unenumerated rights."

The founders did not write "abortion" in invisible ink in the U.S. Constitution. The only way to find it there is to follow the breadcrumbs of the wishful thinking of abortion activists who have abused the courts for almost 50 years to demand death by abortion.

That Judge Ketanji Brown Jackson is biased in favor of abortion can certainly be inferred in what is available of her legal track record, but it is also seen in the <u>direct lobbying campaign of hardened abortion agitators</u> who have insisted for quite a while that she is the right choice for abortion supporters. While Judge Ketanji Brown Jackson in previous hearings <u>has been cagey</u> about her judicial philosophy, the make-up of her abortion industry champions and the pro-abortion record she already has indicate a willingness to put the results she desires over the facts or the law as written.

Consider this, in describing a <u>Constitutional response</u> to efforts to stop peaceful, pro-life speech outside of abortion vendors, the late <u>Judge Antonin Scalia wrote</u>, "if protecting people from unwelcome communications (<u>the governmental interest the Court posits</u>) is a compelling state interest, the First Amendment is a dead letter."

Please protect the U.S. Constitution from dead letter status as well as the rights of pro-life Americans to pray, speak, and act on behalf the preborn and vote NO on the confirmation of Judge Ketanji Brown Jackson to the Supreme Court.
