



Students for Life Action Calls the Harris-Walz Presidential Ticket “Proof that Taxpayers will be Coerced into Funding Loss of Life up until Birth because While Harris just Talks about Abortion, Walz Delivered Death,”

Dear United States House & Senate,

The Democratic Party ticket is now supersized with abortion radicals, as the abortion-talker Kamala Harris is joined by the abortion-doer Tim Walz. While Harris has been wildly ineffective as the Border Czar, she has been the Administration’s Abortion Czar and she is planning to anoint another in Walz, as he has a track record proving his devotion to abortion in all trimesters and to the campaign funders at *Planned Parenthood*. This ticket is proof that taxpayers will be coerced into funding loss of life up until birth, because while Harris just talks about abortion, Walz delivered death to the babies of Minnesota.

As Vice President Kamala Harris chose Minnesota Gov. Tim Walz to be her running mate on the Democratic Party ticket, I noted that putting such abortion extremists together “proves that the Democratic Party has no intention of addressing the problems causing suffering in America but will prioritize ending the lives of those they say might suffer. Cities burned in Minnesota and precious lives have been ended, as Minnesota Gov. Tim Walz pushed his ideology forward, an anti-child agenda destined to devastate the nation if enacted.”

Walz and Harris made tragic history earlier this year, [*visiting an all-trimester Planned Parenthood*](#) abortion facility together in Minnesota to celebrate an industry that profits in the billions by ending life in the womb. Rather than being ashamed of the human rights atrocities taking place, the now-ticket seemed giddy in their support. “Everyone get ready for the language: uterus,” she said cheerily to reporters.

Walz track record on abortion includes:

- Signing into law [the PRO Act](#) (Protect Reproductive Options Act) “[that includes no limitations on when a woman may end the life of her unborn baby,](#)” in January 2023, that law also was written to avoid legal review, according to the [*New York Times*](#), as “Abortion was already protected by a Minnesota Supreme Court decision, but the new law guarded against a future court reversing that precedent as the U.S. Supreme Court did with *Roe v. Wade*.”
- Using his role as [chair of the Democratic Governors Association](#) to push pro-abortion radicalism into the national election.
- Attempting to interfere with the laws of other states [by signing into law a measure to prevent investigation of possible crimes](#) related to abortion.

- Allowing the sterilization of minors under Minnesota law by signing into law an act [creating a “refuge”](#) related to sex-altering protocols.
- Attacking parental rights in the package of laws supported, denying parents or guardians the ability to interact on life-altering, permanent decision.
- Attempting to establish a federal right to abortion when he [was a member of the U.S. House of Representatives](#) as he cosponsored legislation to lock the federal right to abortion into law and voted against efforts to limit abortion.

And if it was any surprise at all, given all those facts, Minnesota has seen a net decline in population [as people flee the state](#). Sadly, if Walz gets anywhere near the White House, Americans can’t just up and leave for a better place with better leaders. We, and the millions of preborn lives who will most certainly be at risk with a Harris-Walz administration, are stuck with them. But only if they win.

As we’ve seen from Vice President Harris, who targeted pro-life groups and activists during her tenure as Attorney General in California and her time as a senator, this kind of politicization and pandering to the worst forms of political left-wing extremism is only going to get worse. And if they ever obtain the power of the executive branch, one can only fathom the nightmare they will unleash.
